### (A) Application Procedures

1. From 16<sup>th</sup> October, 2025 to 16<sup>th</sup> January, 2026, application form (Discretionary Places) can be:

  - b. obtained in person at the General Office during office hours\*
2. All application materials should be submitted to the school general office by hand (Applicants may also choose to submit DP applications via the SSPA e-Platform) from 2<sup>nd</sup> January, 2026 to 16<sup>th</sup> January, 2026.

### (C) Criteria & Weighting

1. Academic Performance 50%
2. Conduct, Extra-curricular Activities & Community Service 20%
3. Interview Performance 30%

(The interview will be conducted in Cantonese and English. A letter of invitation to attend the interview held on 7<sup>th</sup> March 2026 will be sent to **ALL CANDIDATES.**)

### (D) Application materials should include:

1. the completed Lui Cheung Kwong Lutheran College S.1 Application Form attached with a recent photo;
2. a photocopy of HKID Card and birth registration document;
3. the completed Application Form for S.1 Discretionary Places issued by EDB;
4. photocopies of P.5 & P.6 academic reports;
5. photocopies of Qualifications/ Certificates/ Awards; and
6. a stamped self-addressed envelope (with the name and address of the student).

\* Recommendation Letter from primary school is **NOT** necessary.

### (E) Results

Our school would notify successful applicants of their inclusion in the Successful Lists for Discretionary Places on 31<sup>st</sup> March, 2026. **Admission results will be announced by the EDB on 7<sup>th</sup> July, 2026.**
